Artsy Fartsy LLC (“Artsy Fartsy”, “we,” or “our”) is a process art studio that teaches children about art while using a wide range of artistic materials & techniques. As the parent or legal guardian of your child & by your signature, you agree to the below:

1. We strive to create a beautiful, fun, positive, & safe environment for our students & parents. You & your child agree to treat all participants of Artsy Fartsy’s art classes with respect & kindness. This is a strict no bullying space. We also ask that parents attending class adhere to a no gossip policy.
2. Our classes tend to get pretty messy, you are responsible to make sure your child is dressed properly which means wearing proper shoes at all times & wearing clothes meant to get dirty or wearing an apron smock.
3. As a process art studio, we use a wide range of materials during our projects, including but not limited to hot glue, paint, chalk, pastels, marbles, play dough, hammers, wax, fibers, and other sharp objects or objects that can be dangerous if swallowed. ***We do our very best to monitor every child’s activities here, accidents can happen from time to time due to inherent risk of using these materials.*** You understand that these materials are not meant for consumption & will instruct your child not to consume any materials & conduct themselves in a safe way.
4. The safety of your child & other children is of our utmost priority. You acknowledge that your child has no physical, emotional, or social conditions that make it dangerous or unwise for your child to safely participate in our art classes. Please refrain from running in the studio, it is dangerous for both your child & others around him/her.
5. We love promoting process-based art & sharing with others. We may take photographs, video, and/or audio (the “Media”) during our class to post on our social media. We are the sole owner of our Media and may use the Media in any way in our sole discretion. You grant us permission to use your child’s image without restriction & waive your right to inspect or approve the Media.
6. You give permission for your child to participate in Artsy Fartsy Process Art Studio’s art classes. You release & hold Artsy Fartsy Process Art Studio harmless from any & all liability that may arise in connection with Artsy Fartsy’s art classes and/or camps.

8. This Liability Waiver is governed by the laws of California.
